The Program

Phil Lebovitz, M.D., Chicago Institute for Psychoanalysis faculty member and IPA Research Programme Fellow, presents the findings of 30 years of research on psychoanalytic treatment by Institute clinicians. Dr. Lebovitz shows how the application of these findings can significantly improve the effectiveness of psychoanalytic and psychodynamic treatment.

Based on interviews of psychoanalytic patients two or more years following termination of treatment, the research presents a diagnostic framework based on an understanding of personality development. It shows how this developmental perspective helps clinicians realistically assess the dimensions of change for their patients. Clinicians are then able to measure what areas of personality have shown change and what areas have not been sufficiently engaged in the treatment process, resulting in less or no change.

At the conclusion of the conference participants will be able to draw on the concepts of defense transference, cycling of themes, and self-analytic function to review their previous approaches to psychoanalytic and psychodynamic therapy. They will be able to adapt these ideas to their own clinical interventions and will have enhanced their ability to assess change during and at the conclusion of treatment.

Phil S. Lebovitz, MD is a faculty member at the Chicago Institute for Psychoanalysis. He is a training and supervising analyst at the Chicago Institute and a Geographic Rule training and supervising analyst at the Wisconsin Psychoanalytic Institute in Milwaukee. He is also Associate Clinical Professor of Psychiatry and Behavioral Science at Rosalind Franklin University of Health Science/The Chicago Medical School. Dr. Lebovitz serves on the board of the Accreditation Council for Psychoanalytic Education (ACPE) and is Treasurer of ACPE. His work has focused on follow up studies of patients completing psychoanalysis in an effort to assess what changes and how. Constructing a method to do the same with patients treated with psychodynamic psychotherapy is a current challenge.
